The Phase-I Preliminary Exam and Phase II Main Exam. for the post of UDC was held on 14.07.2019 and 01.09.2019 respectively. The <u>Phase – III Computer Skill Test</u> for the Recruitment to the post of UDC was held on <u>20th October</u>, <u>2019 and 1st December</u>, <u>2019 (for Maharashtra Region)</u>.

The Result of Computer Skill Test for the post of UDC in respect of remaining 07 Regions – Gujarat, Karnataka, Maharashtra, Tamilnadu, Telangana, Uttar Pradesh & West Bengal along with Combined Merit List of Main Examination along with Combined Merit List of Phase-II Main Examination is uploaded (Region wise in Order of Merit) on the ESIC website www.esic.nic.in vide Notice dated: 30.01.2020.

The Phase III Computer Skill Test (CST) is only qualifying in nature.
