



Banking Current Affairs

- ✦ Private sector lender Yes Bank has partnered with mobile payments switch TerraPay to enable real-time money transfer to bank accounts in India. Powered by TerraPay's global clearing and settlement service, the partnership will make it faster and convenient for consumers to send money to any bank account.
- ✦ RBI has placed Central Bank of India under prompt corrective action (PCA) which puts restricts on banking activities such as from lending, hiring and expanding branches. So far, RBI has triggered PCAs for four banks - IDBI Bank, UCO Bank, Dena Bank and Indian Overseas Bank.
- ✦ RBI initiated prompt corrective action (PCA) on Bank of Maharashtra placing a restriction on the banking activities. This is the sixth bank to be placed under PCA by the RBI and of this five banks were placed under PCA in the last three months. RBI has initiated PCA on Central Bank of India, IDBI Bank, UCO Bank, Dena Bank and Indian Overseas Bank.
- ✦ State Bank of India has entered into a tie-up with Tirumala Milk Products, a South- based company which was acquired by Groupe Lactalis in 2014, to provide loans to dairy farmers who supply milk to the latter.
- ✦ IDBI Bank has started insolvency resolution process against Lanco Infratech Ltd. following a directive from the Reserve Bank of India (RBI). This is the first resolution process initiated by the lenders against 12 large borrowers identified by the RBI recently.
- ✦ Banks' credit growth was up 6.02% to Rs76,58,212 crore in the fortnight ended 9 June from Rs72,22,939 crore in the same period of fiscal 2016, according to the data released by the Reserve Bank of India (RBI).
- ✦ Reserve Bank of India reconstituted the Oversight Committee by appointing three more members. The high-level panel was formed to examine the process to resolve mounting bad loans in the banking sector. According to the RBI former chief vigilance commissioner, Pradeep Kumar will head the now reconstituted 5-member panel. The other members of the committee are former SBI Chairman Janki Ballabh, former Canara Bank Chairman and MD MBN Rao, former Chairman of L&T Finance YM Deosthalee and S Raman, member SEBI.
- ✦ The central bank has extended the scope of Banking Ombudsman Scheme. As per RBI, under the amended scheme, a customer would also be able to lodge a

complaint against the bank for its non-adherence to RBI instructions with regard to mobile banking/ electronic banking services in India. As per the amendment, the pecuniary jurisdiction of the Banking Ombudsman to pass an award has been doubled to 20 lakh rupees.

- ✦ In continuation of issuing of Rs500 denomination banknotes in Mahatma Gandhi (new) series from time to time which are currently legal tender, a new batch of banknotes with inset letter "A" in both the number panels, bearing the signature of Dr. Urjit R. Patel.
- ✦ According to the Code Compliance Rating of banks done by the Banking Codes and Standards Board of India (BCSBI) 2017, only one (IDBI Bank) out of 26 public sector banks and eight out of 17 private sector banks got 'high' rating for their adherence to code compliance.
- ✦ Canara Bank has inked pact with The New India Assurance Company Ltd. to sell policies through its branches.
- ✦ SBI cut the interest rate on home loans above Rs 75 lakh by 10 basis points (bps) to 8.60 percent. For salaried women borrowers, the loans will be offered at 8.55 percent. According to SBI, the new rates will be effective from June 15. The home loan rates offered are lowest in the industry.
- ✦ Indian Overseas Bank has launched the Retail Mart, a retail lending concept, in Kerala's capital city.

- ✦ Axis Bank Ltd announced biodegradable prepaid gift cards on the occasion of World Environment Day (05th June). With this, the bank has become the first to introduce biodegradable cards in the country.

- ✦ ADB & PNB signed a \$100 million loan to be guaranteed by the Govt. of India that will finance large solar rooftop systems on industrial & commercial buildings throughout India.
- ✦ RBI has initiated prompt corrective action (PCA) for Dena Bank in view of high net non-performing assets & negative return on assets. Prompt Corrective Action is the action which will not have any material impact on the performance of the bank in fact it will contribute to improve the internal controls of the bank & improvement in its activities.
- ✦ SBI & the World Bank announced that they had financed 100 MW of rooftop solar projects worth Rs400 crore in India.
- ✦ Bank of India conducted a mass-contact programme, 'Star Mahotsav', across its branch network. The thrust was in contacting every customer at their doorstep for recovery of bad loans, disbursement of retail loan, including housing & vehicle loan, disbursement under MSME & agriculture, & promotion of its products including debit/credit cards, PoS machines, internet banking, etc.
- ✦ On the basis of an assessment of the current & evolving macroeconomic situation at its meeting today, the Monetary Policy Committee (MPC) decided to:
- ✦ Keep the policy repo rate under the liquidity adjustment facility (LAF) unchanged at 6.25 per cent.
- ✦ Consequently, the reverse repo rate under the LAF remains at 6.0 per cent, and
- ✦ The Marginal Standing Facility (MSF) rate & the Bank Rate at 6.50 per cent.
- ✦ Vijaya Bank is going to develop as many as 100 digital villages in various States of the country as part of its initiative to promote digital banking among the rural population.

Schemes/Portals/Missions Launched

- ✦ The Minister of State for Public Grievances & Pensions, Atomic Energy and Space, Dr. Jitendra Singh launched a new training program 'Comprehensive Online Modified Modules on Induction Training' (COMMIT) for State Government officials. The objective of this training program is to improve the public service delivery mechanism and provide citizen-centric administration through capacity building of officials who interact with the citizens on day-to-day basis. COMMIT will be launched in 6 States of Assam, Haryana, Maharashtra, Tamil Nadu, Telangana and West Bengal initially on the pilot basis during the current financial year 2017-18 and within next year it is expected to cover all India level.

- ✦ MSME Minister Mr. Kalraj Mishra has launched the Digital MSME Scheme and also exchanged three MoUs with SAP India, Intel and HMT. United Nations has recently declared 27th June as the UN Day for MSMEs. It has been celebrated for recognizing the importance of the crucial role that the sector plays both in terms of job creation and contribution towards economic growth. The MSME has a total budget of Rs. 85,705 Crore including Government of India's contribution of Rs. 58,105 crore during 2017-18 to 2019-20. International Trade Centre (ITC) has celebrated the first International MSME Day on June 27, 2017. The theme of MSME is 'Small business - big impact'.
- ✦ Actress Priyanka Chopra has been appointed as the ambassador for government's flagship Skill India campaign, with the National Skill Development Corporation.
- ✦ Ministry of Health and Family Welfare has launched the Intensified Diarrhea Control Fortnight (IDCF) in order to intensify efforts to reduce child deaths due to diarrhoea. It aims to create mass awareness about the most effective and low-cost diarrhoea treatment, a combination of Oral Rehydration Salt (ORS) solution and Zinc tablets.
- ✦ External Affairs Minister Sushma Swaraj has inaugurated Know India Programme (KIP) for young overseas Indians. This programme is aimed at promoting awareness on different facets of life in India and the progress made by the country in various fields such as economic and education. It provides a unique forum for students and young professionals of Indian origin to visit India, share their views, expectations and experiences and develop closer bonds with the contemporary India.
- ✦ Minister for Science & Technology Dr. Harshvardhan launched a Mobile App "Celebrating Yoga" developed by Ministry of Science & Technology in New Delhi. The purpose of the App is to popularize Yoga and encourage people to participate in it for a scientifically healthy living.
- ✦ Shri Piyush Goyal, Minister of State (IC) for Power, Coal, New and Renewable Energy and Mines launched the Energy Conservation Building Code 2017 (ECBC 2017). Developed by Ministry of Power and Bureau of Energy Efficiency (BEE), ECBC 2017 prescribes the energy performance standards for new commercial buildings to be constructed across India.
- ✦ The Department of Science and Technology (DST) launched the Visiting Advanced Joint Research Faculty (VAJRA) scheme in a bid to bring together the Indian scientists abroad and India-based researchers for

conducting joint researches in India. The motive behind the launching of VAJRA scheme is to bring the best of the world to India and conduct research in the country itself. It aims to convert brain-drain into brain-gain.

- ✦ In order to ensure smooth GST implementation from 1st July, the Ministry of Electronics and Information Technology has launched a dedicated Webpage for facilitating taxpayers with regard to addressing issues related to Information Technology Services and Electronics goods.
- ✦ The government of India has launched 'Tele Law' service to provide legal aid for the people living in rural areas through video conferencing.
- ✦ To enhance the passenger's experience by upgrading existing fleet of coaches with better furnishing, aesthetics & amenities and better safety features with a view to provide a safe and comfortable travel, Minister of Railways Shri Suresh Prabhu has launched MISSION RETRO-FITMENT in Rail Bhavan, New Delhi.
- ✦ President Pranab Mukherjee launched the 'Selfie with Daughter' mobile application, aimed at raising awareness about female foeticide & sex selection. The aim is to motivate society to feel proud to be parents of a girl child, which, in turn, will result in improving child sex ratio.
- ✦ Civil Aviation Ministry is adding a digital experience for Air travelers through 'DigiYatra' Platform in New Delhi. This initiative aims at bringing together entire industry to develop a digital ecosystem that will deliver customers a seamless & paperless service experience at every stage of journey.
- ✦ Shri J P Nadda has launched 'Skill for Life, Save a Life' initiative to promote skill development in the health sector. The Initiative aims to upscale the quantity & quality of trained professionals in the healthcare system.
- ✦ Telangana Govt. has launched a digital wallet, named T-Wallet, which doesn't charge transaction fee from consumers. T-Wallet is bi-directional in nature. While consumers use it for public & private transactions, the Govt. can use it to make payments to various beneficiaries.
- ✦ Telangana Govt. has recently launched the single-women pensions scheme across the state. Single women will be given Rs 1,000 per month. It is the first such scheme in India.
- ✦ Maharashtra CM Devendra Fadnavis launched a web portal 'Mahaswayam' that will cater to job seekers, employers, entrepreneurs, & training institutes who can avail details regarding skill development & employment.

- ✦ Minister for road transport & highways Nitin Gadkari has launched 'INAM PRO+'. It is an e-commerce platform for construction & infrastructure raw material for Govt. & private procurement.
- ✦ CM of Karnataka Siddaramaiah has recently launched India's first public bicycle sharing (PBS) initiative 'Trin Trin' in Mysuru. The World Bank, Global Environmental Fund, & state govt have jointly funded the initiative. Mysuru is the first city in India to have a public bicycle sharing system.
- ✦ TRAI launched three new apps to help customers rate quality of services, speed & performance. The three new apps are Mycall app, MySpeed app & 'Do not disturb (DND 2.0)' app. The MyCall app, is an Android application for crowdsourced voice call quality monitoring. MySpeed app will enable TRAI to obtain test-data from users in all service areas, without any action by the users. The DND service app will enable users to register their mobile number under DND to avoid unsolicited commercial communication/telemarketing calls/SMS.

State in News

- ✦ Prime Minister Narendra Modi inaugurated various irrigation and water-related initiatives at Aji Dam in Rajkot, Gujarat including the filling of Aji dam with Narmada waters under Sauni Yojana.
- ✦ Odisha is all set to become the first state in the country to have a blood bank for the cattle.
- ✦ Uttar Pradesh Government signed an agreement with Asian Development Bank (ADB) for a loan of 1950 crore rupees for strengthening of roads in different district. As per agreement, ADB will provide the loan amount for Uttar Pradesh Main District Roads Development Project of 2782 crore rupees cost. State

government will spend 832 crore rupees from its own resources on the project. Project is scheduled to be completed by 2024 and ADB will provide the loan for the period of 25 years on the interest rate of 2 percent.

- ✦ Government has cleared the proposal for setting up a new airport in Jewar in Greater Noida. Civil Aviation Minister Ashok Gajapathi Raju stated that in-principle approval for a greenfield airport at Jewar has been granted to cater to the growing flying requirements of National Capital Region.
- ✦ Prime Minister Narendra Modi has inaugurated the Kochi Metro. He took a ride in the Metro from Palarivattom station to Pathadippalam station. Kochi Metro is the first public transport system to reserve jobs for members of the third sex and it will be manned mainly by women a self-help group.
- ✦ Punjab Government announced free education for girls in government schools and colleges from Nursery to Ph.D. This is the major step towards women empowerment by Punjab CM Captain Amarinder Singh. Reservation for women in Panchayati Raj Institutions and Urban Local Bodies has already been increased by the government from 33 per cent to 50 per cent.
- ✦ Meghalaya government has signed two MoUs with the State Bank of India as a part of an initiative towards migrating government transactions to digital mode. With the implementation of the Goods and Services Tax(GST), these MoUs are expected to give dealers and other citizens the desired platform for conducting financial transactions with the state government on a digital platform.
- ✦ Indore, the commercial capital of Madhya Pradesh reportedly become the first city in India where the robot is being used on an experimental basis to control its ever growing and unruly traffic.
- ✦ Under the Swachh Bharat Mission Gramin (SBM-G), rural Uttarakhand and rural Haryana have declared themselves as the 4th and 5th Open Defecation Free (ODF) States of India, respectively. These two states joined the league of Sikkim, Himachal Pradesh, and Kerala.
- ✦ Bengaluru has become the country's first city where one can have fuel delivered at one's doorstep, just like milk and newspapers. Mypetrolpump, a one-year-old startup, conducted a soft launch with three delivery vehicles -each with a capacity of 950 liters.
- ✦ The state government approved 53 urban projects with a total investment of Rs 538 crore under the Atal Mission for Rejuvenation and Urban Transformation (AMRUT). The scheme aimed at strengthening

drinking water distribution network, development of sewerage system, storm water management, up-gradation of city transport system and development of amusement parks. Bhubaneswar, Cuttack, Puri, Berhampur, Rourkela, Sambalpur, Balasore, Bhadrak and Baripada are the nine places where the scheme is being implemented with fund sharing patten of 50:50 between the Centre and state government.

- ✦ Mizoram Health Minister Lal Thanzara has launched the 'Test and Treat Strategy' of the Mizoram state AIDS Control Society (MSACS) to improve treatment for HIV affected people in the state. Under the 'Test and Treat Strategy', the HIV-affected people would be given free Anti Retrovira Therapy (ART) irrespective of the CD4 count.
- ✦ Union Minister of State (Independent Charge) for Development of North Eastern Region (DoNER), Dr Jitendra Singh announced the launch of "Hill Area Development Programme" (HADP) for Northeast in Imphal, Manipur.
- ✦ Kolkata, the 'City of Joy' is about to experience a wonder in the form of an underwater Metro train which will run beneath the Hooghly river.
- ✦ According to the Child Rights and You (CRY) report, over 8 lakh children in India between the age group 5 and 6 years are engaged in child labor. Uttar Pradesh has the highest number of 2,50,672 children engaged in labor.
- ✦ State-run power giant National Thermal Power Corporation (NTPC) has energized India's first 150 kWp canal top solar PV System on cooling water (CW) channel inside power station premises at its 2,320 MW, Mouda Thermal Power Project, near Nagpur in Maharashtra.
- ✦ Telangana government has launched a website to facilitate the online sale or purchase of cattle through pashubazar.telangana.gov.in website will help farmers as the cattle need not be brought to shandies every time and farmers can save on transportation cost on cattle.
- ✦ **'Vatsalya - Maatri Amrit Kosh', a National Human Milk Bank & Lactation Counselling Centre** was inaugurated at the Lady Hardinge Medical College (LHMC) in New Delhi. The Vatsalya - Maatri Amrit Kosh will be the largest milk bank & lactation counseling center available in the North India. It is established in collaboration with the Norwegian Govt, Oslo University & Norway-India Partnership Initiative (NIPI).
- ✦ Govt. of Tamil Nadu has signed MoU with the Union Civil Aviation Ministry for the implementation of the UDAN scheme in the state. Under the scheme, three of the tier-

two industrial towns such as Hosur, Salem & Neyveli are to be developed in the first phase.

- ✦ The Centre has approved the modifications to the Prevention of Cruelty to Animals (Karnataka Amendment) Bill 2017 to pave way for organizing 'kambala'. The Bill proposes to exempt 'kambala' from the ambit of the Prevention of Cruelty to Animals Act 1960.
- ✦ NITI Aayog has **launched SATH, a program providing 'Sustainable Action for Transforming Human Capital' with the State Govt.s.** The vision of the program is to initiate transformation in the education & health sectors. SATH programme will be implemented by NITI Aayog along with global consultancy McKinsey & Company & IPE Global consortium in the three selected States after the signing of MoUs.
- ✦ Wedding ceremonies in Kerala are all set to become 'green', with the state Govt. coming out with a green protocol to make auspicious occasions more nature-friendly. With the implementation of the protocol, plastic & other non-biodegradable articles including disposable glasses & plates & thermocol decorations will be kept at bay from marriage functions.
- ✦ Delhi Police launched patrolling on bicycle to improve policing in congested localities in trans-Yamuna region of the city. The move is also being billed as a green initiative.
- ✦ The first Mega Food Park in the state of Odisha MITS Mega Food Park Pvt. Ltd. at Rayagada has been inaugurated by Smt. Harsimrat Kaur Badal, Minister of Food Processing Industries.
- ✦ Odisha is the first State in India to have developed an automatic public address system that can be activated along its entire coast. The State Govt. is all set to commission the ambitious Early Warning Dissemination System (EWDS) that would enable loud sirens go off simultaneously from towers at 122 locations by July 2017.
- ✦ Varanasi will get the country's first 'freight village' spread over around 100 acres. It will be developed by the Inland Waterways Authority of India (IWAI) in Varanasi, Uttar Pradesh.
- ✦ Ministry of Rural Development has selected Vizianagaram district in Andhra Pradesh as one among the 17 districts across the nation for the MGNREGA annual award.
- ✦ Energy Efficiency Services Ltd. has initiated a French Agency-funded project to retrofit 10 lakh conventional street lights with LED lights in Gram Panchayats of 7 districts in Andhra Pradesh. This is the first project for rural LED street lighting in the country under the Centre's Street Lighting National Project (SLNP).

New Appointments

- ✦ Senior diplomat Vijay Keshav Gokhale was appointed as the economic relations secretary in the Ministry of External Affairs (MEA). The Appointments Committee of the Cabinet has approved his appointment.
- ✦ British Prime Minister Theresa May narrowly won the confidence vote in the parliament, winning her first major test as the Prime Minister of a minority government in the United Kingdom (UK). With this, May was finally confirmed as the British Prime Minister three weeks after the election.
- ✦ Rajiv Kumar was appointed as the Chief Secretary of Uttar Pradesh. His appointment was approved by the Uttar Pradesh Government. He has replaced Rahul Prasad Bhatnagar.
- ✦ The Union Government (Ministry of Textiles) has appointed Shri Rajesh V. Shah as Chairperson on the Board of Governors of the National Institute of Fashion Technology (NIFT). He has replaced Shri Chetan Chauha.
- ✦ Former chief economic advisor Kaushik Basu has taken over as president of the International Economic Association (IEA). Basu's three-year term started from June 23.
- ✦ Romanian President Klaus Iohannis appointed Social Democrat Mihai Tudose as the Prime Minister and mandated him to form a new government. He has been appointed as Prime minister after the ruling Social Democrat Party (PSD) removed its own government following an internal power row.
- ✦ Jammu and Kashmir Governor N N Vohra has been appointed the president of the India International Centre (IIC) - one of the premier cultural institutions in the country.
- ✦ Indian nominee Neeru Chadha became the first Indian Woman to be elected as the Member of International Tribunal for the Law of the Sea (ITLOS). She will have a nine-year term as the Judge at ITLOS from 2017 to 2026. Currently, an eminent jurist from India P Chandrasekhara Rao is a judge at the tribunal.
- ✦ IDFC Ltd announced the elevation of its CFO Sunil Kakar as the Managing Director and Chief Executive Officer of the company with effect from July 16 for three years. Mr. Kakar has also been appointed as additional director.
- ✦ The government of India has appointed a senior executive of Tata Consultancy Services Ramanathan Ramanan to head Atal Innovation Mission, its initiative to promote entrepreneurship in the country. Ramanathan Ramanan, senior vice president at TCS,

has been appointed as mission director of Atal Innovation Mission.

- ✦ Bihar Governor Ram Nath Kovind has resigned from his gubernatorial post. The resignation follows his nomination as the ruling NDA's presidential candidate.
- ✦ Ayurveda physician 'Vaidya' Rajesh Kotecha has been appointed as special secretary in Ayush Ministry. The Appointments Committee of the Cabinet has approved Kotecha's appointment for three years on a contract basis, according to an order issued by Department of Personnel and Training (DoPT).
- ✦ Saudi Arabia's King Salman has appointed his son, Mohammed bin Salman, as heir, in a major reshuffle. The newly-announced crown prince was also named deputy prime minister and maintained his post as defense minister.
- ✦ United Nations Children's Fund (UNICEF) announced, on the World Refugee Day (20 June), the appointment of Muzoon Almellehan, a 19-year-old education activist, and Syrian refugee, as its newest - and youngest - Goodwill Ambassador. The appointment makes Muzoon the first person with official refugee status to become an Ambassador for UNICEF.
- ✦ Justice Dalveer Bhandari has been nominated by India as its candidate for another nine-year term as judge of the International Court of Justice (ICJ), the principal judicial organ of the UN.

- ✦ Leo Varadkar, a 38-year-old Indian-origin doctor, scripted history by becoming Ireland's youngest and the first openly gay Prime Minister of the Catholic-majority country.
- ✦ Gaitri Issar Kumar was named as India's Ambassador to Belgium and the European Union & Reenat Sandhu was named as India's new Ambassador to Italy. Ajit Vinayak Gupte named as India's Ambassador to Denmark.
- ✦ SEBI has given conditional approval for the appointment of Vikram Limaye as the MD & CEO of the NSE.
- ✦ Lakshmi Vilas Bank (LVB) has appointed B K Manjunath as a part-time chairman for three years.
- ✦ K G Karmakar & Gauri Shankar were appointed as Independent Directors of India Post Payments Bank (IPPB) for 3 years.
- ✦ Economic Affairs Secretary Shaktikanta Das announced his retirement as the Corporate Affairs Secretary. He will be succeeded by Tapan Ray, who will take the additional charges as the new Economic Affairs Secretary.
- ✦ RBI appointed S. Ganesh Kumar as Executive Director. His appointment is consequent upon voluntary retirement of Chandan Sinha.
- ✦ Sanjiv Singh has taken over as the Chairman of Indian Oil Corporation. He replaces B Ashok.
- ✦ UN General Assembly elected Slovak foreign minister Miroslav Lajcak to be the next president of the 193-member powerful body.
- ✦ Nirupama Rao appointed as the public policy fellow of Sino-India ties a top American think-tank.
- ✦ Jet Airways has announced the appointment of Vinay Dube as its Chief Executive Officer (CEO).
- ✦ Shashi Shekar Vempati has been appointed as the CEO of Prasar Bharati. He will replace Rajeev Singh.
- ✦ Amul Thapar, an Indian-American legal luminary, appointed as a judge on the US Court of Appeals for the Sixth Circuit by President Donald Trump.
- ✦ Indian-Origin Leo Varadkar is set to become the Republic of Ireland's next PM after winning the leadership of the Fine Gael party. He will become the first gay PM & will also be the country's youngest ever leader. He will succeed Enda Kenny.
- ✦ Aleksandar Vucic has been sworn in as Serbia's new president, promising to work for peace & stability in the war-weary Balkans while strengthening the country's armed forces.
- ✦ Veteran Nepalese politician Sher Bahadur Deuba was elected as Nepal's PM for the fourth time.
- ✦ Senior bureaucrat Hoshiar Singh has been appointed as Registrar of Copyrights.

- ✦ Urban development secretary Rajiv Gauba will be the new home secretary after the completion of the tenure of Rajiv Mehrishi on August 30. Other important Appointments are as follows-

- ✦ Google has been fined 2.42 billion euros (\$2.7 Billion) by the European Commission after it ruled the company had abused its power by promoting its own shopping comparison service at the top of search results. It is the biggest fine the EU has ever imposed on a single company in an antitrust case.
- ✦ World Bank has cleared a USD 250-million loan for making Indian youth more employable through reskilling, in a move that is seen to aid the Skill India Mission. Under the program, adults in 15-59 years of age, underemployed or unemployed, will get the skill training.
- ✦ SpiceJet Ltd has become the world's best-performing airline stock – with \$26 billion in plane orders to boot. The company's co-founder and chairman, Ajay Singh, has played the white knight, injecting capital, cutting loss-making routes and aggressively adding capacity in one of the world's fastest growing markets.
- ✦ China-led Asian Infrastructure Investment Bank has approved USD 150 million equity investment loan to the India Infrastructure Fund. It is the bank's first such loan to fund private projects. The bank, in which India is a lead partner, has approved two loans and one equity investment totaling USD 324 million to support infrastructure projects in India, Georgia and Tajikistan.
- ✦ The country's competition watchdog CCI imposed a penalty of Rs 87 crore on Korean carmaker Hyundai Motor India for anticompetitive conduct.
- ✦ Pension Fund Regulatory and Development Authority (PFRDA) has now introduced "APY@eNPS" which involves a complete digital enrolment process. This is the latest in the series of various initiatives taken by PFRDA for expansion of outreach of Atal Pension

- Yojana (APY), to give the additional push to cover the as yet unreached population with greater ease.
- ✦ The government has roped in Bollywood megastar Amitabh Bachchan to promote Goods and Services Tax (GST), ahead of the sweeping tax reform's implementation scheduled from July 1. The Central Board of Excise and Customs (CBEC) will be making the 74-year-old Bachchan brand ambassador for GST.
- ✦ Online financial services marketplace BankBazaar has begun its operations in Malaysia to strengthen its presence in South East Asia.
- ✦ Hike Messenger launched the new version of the app with a completely new interface and the addition of a mobile wallet, in partnership with YES Bank. With Unified Payments Interface support enabled in Hike 5.0, users can now do free and instant bank-to-bank transfers with their friends.
- ✦ Uber co-founder Travis Kalanick has resigned from his position as chief executive of the \$68bn ride-hailing app following a tumultuous six months of scandal.
- ✦ Capital markets regulator, SEBI relaxed takeover norms for the acquisition of stressed assets of listed companies to help the government and the RBI in their efforts to tackle bad loans. The Important decisions are as follows:
 1. Restructuring in stressed companies.
 2. Resolution plans approved under the Insolvency and Bankruptcy Code, 2016
 3. Extension of Lock-in-relaxation to Category II Alternative Investment Funds (AIF)
 4. Consultation paper on Easing of access norms for investment by FPIs
- ✦ World Bank's Board of Executive Directors has approved a loan assistance of 44 million dollars for the Assam State Public Finance Institutional Reforms (ASPIRe) Project. The project aims at improving predictability and transparency in budget execution and efficiency in tax administration in Assam.
- ✦ Employees Provident Fund Organisation (EPFO) has signed an MoU with the Housing and Urban Development Corporation (HUDCO) to enable members of its housing scheme to avail subsidy and interest subvention under the Pradhan Mantri Awas Yojana (PMAY). Under the housing scheme, the EPFO allows its subscribers for withdrawing up to 90 per cent of their EPF accumulations to buy homes. Now, EPFO members can avail interest subsidy upto two lakh twenty thousand rupees in Credit Linked Subsidy Scheme through HUDCO and National Housing Bank

for those members whose annual income is less than the amount specified in Pradhan Mantri Awas Yojna.

- ✦ The council revised rates on 66 items such as pickles, sauces, fruit preserves, insulin, cashew nuts, insulin, school bags, coloring books, notebooks, printers, cutlery, agarbattis and cinema tickets, following representations from industry. Restaurants, manufacturers and traders having a turnover of up to Rs 75 lakh can avail of the composition scheme with lower rates of 5%, 2%, and 1%, respectively, with lower compliance, against Rs 50 lakh previously.
- ✦ Insurance Regulatory and Development Authority of India (IRDAI) has taken over the administration of Sahara India Life Insurance, a first of its kind move in the insurance sector.
- ✦ The Govt. has set up 18 sectoral groups, comprising senior members from the Centre & the States, to ensure the smooth rollout of the Goods & Services Tax. The 18 groups pertain to sectors such as banking & insurance, textiles, exports, information technology, transport, & oil & gas.
- ✦ Union Cabinet recently gave its nod for SEBI to enter into two separate MoU with securities market regulators of the European Union & Iran.
- ✦ Union Cabinet approved the proposed MoU between Export-Import Bank of India (EXIM Bank) & Export-Import Bank of Korea (KEXIM) for export credit of USD 9 billion for infrastructural development in India & for the supply of goods & services as part of projects in third countries.
- ✦ India's GDP grew 6.1 percent year-on-year during the January-March, 2017 period according to Govt. data. With this, India loses its status of the world's fastest growing economy. China's GDP grew 6.9 percent during the same quarter. The GDP growth rate for the full year (2016-17) came in at 7.1 percent in line.
- ✦ Bharti Airtel has received approvals from SEBI, BSE & the National Stock Exchange of India for its proposed merger with Telenor India.
- ✦ The GST (Goods & Services Tax) Council has cleared the pending rules, including transition provisions & returns, with all the States agreeing to the July 01st 2017 rollout of the tax. Transition rules have been cleared & everybody has agreed for a July 1 rollout," according to Kerala Finance Minister Thomas Isaac. The GST Council last month fitted over 1,200 goods & 500 services in the tax brackets of 5, 12, 18 & 28 per cent.
- ✦ Reliance Communications (RCom) Chairman Anil Ambani has announced that the merged entities of RCom & Airtel will be called Aircom. These merged entities are Reliance Communications & Maxis Communications Berhad (MCB).

- ✦ TATA Projects has announced the launch of Green Thumb, an initiative to enhance the green cover. This new initiative of the infrastructure company coincides with World Environment Day (05th June).
- ✦ NSE launched its international exchange in the Gujarat International Finance Tec-City (GIFT City). NSE IFSC Ltd, the global exchange is promoted by NSE.
- ✦ The proposed merger between Aadhar Housing Finance & DHFL Vysya Housing Finance has hit the final lap with it got the nod from housing finance regulator National Housing Bank (NHB).
- ✦ Ransomware attacks have prompted Microsoft to sign an agreement to acquire Hexadite. This deal cost \$100 million.

Sports

- ✦ BCCI announced the formation of a special seven-member committee to identify the 'few critical points' for the general body of the cricket board to consider before they are submitted to the Supreme Court. This committee will be responsible for identifying those points that are difficult to be implemented, in regards to the Justice RM Lodha Committee reforms. The seven-member committee has Rajeev Shukla, Sourav Ganguly, Naba Bhattacharjee, TC Mathew, Jay Shah, Amitabh Choudhary and Anirudh Chaudhary.
- ✦ The Indian shooting squad has finished a creditable second at the ISSF Junior World Championship with three gold, two silver and three bronze medals in Suhl, Germany. India picked up a gold and silver in the team and individual sections of the 25m pistol junior men's event. Anish Bhanwala won three medals, one of each colour. China topped the tally in the rifle/pistol tournament with 19 medals, including eight golds.
- ✦ Swiss legend Roger Federer has clinched his ninth Halle Open title after beating Alexander Zverev 6-1, 6-3 in the final.
- ✦ Srinivas Gokulnath from Maharashtra created history by becoming the first Indian to complete the 4,941-km Race Across America (RAAM) in solo category. Considered to be the toughest cycle race in the world, he cycled for 11 days, 18 hours and 45 minutes.
- ✦ Bhumika Sharma, another Indian has become Miss World in bodybuilding championship. Dehradun's girl gained maximum points in three categories - individual posing, body posing and fall in that eventually bagged her the Miss World title and the gold medal at the world championship in Venice, Italy.
- ✦ India became the team to score the most 300-plus totals in One Day International (ODI) Cricket. India did so when they scored a total of 310 for the loss of five

wickets in the second ODI against West Indies. It was the 96th time that India crossed the 300-run mark, surpassing Australia's 95.

- ✦ The fast-rising Ankush Dahiya (60kg) clinched a gold while the experienced L Devendro Singh (52kg) settled for a silver medal on the final day of the Ulaanbaatar Cup boxing tournament in Mongolia.
- ✦ India's Kidambi Srikanth has lifted the Indonesia Open Super Series badminton title by defeating Japanese qualifier Kazumasa Sakai in straight games 21-11, 21-19 in the Men's Singles final at Jakarta, Indonesia.
- ✦ Haryana's Anish Bhanwala gave a robust start for the Indian challenge by clinching the 25-metre standard pistol gold with a world junior record in the Junior World Shooting Championship in Suhl, Germany.
- ✦ India won six medals in the Wushu competition of the first ever BRICS Games, which concluded in Guangzhou, China recently. The medals haul comprised two each in gold, silver, and bronze. China will host the 9th BRICS summit in September 2017.
- ✦ Anil Kumble, the former Indian Captain, resigned from the post of Head Coach of the Indian Cricket team. His resignation came before the limited-overs tour of the West Indies team.
- ✦ Shashikant Kutwal has won the gold medal at the 17th World Individual Chess Championship for differently-abled. The World Chess Championship was held in Slovakia.
- ✦ India's Jitu Rai and Heena Sidhu combined to clinch the gold medal in mixed team 10m air pistol event of the ISSF World Cup, beating Russia in the final in Gabala, Azerbaijan. Rafael Nadal's magnificent run to a 10th French Open title has earned the Spaniard a move into second in the latest ATP world rankings.
- ✦ Lewis Hamilton won the Canadian Grand Prix for the sixth time. He won against Sebastian Vettel's overall championship and lead to 12 points.
- ✦ Indian captain Virat Kohli displaced South Africa's AB de Villiers as the No.1 ranked ODI batsman in the world while Australian fast bowler Josh Hazlewood took over from Proteas pacer Kagiso Rabada as the No.1 ranked bowler.
- ✦ Haryana's Anish Bhanwala gave a robust start for the Indian challenge by clinching the 25-metre standard pistol gold with a world junior record in the Junior World Shooting Championship in Suhl, Germany.
- ✦ In Badminton, ace Indian shuttler Kidambi Srikanth has lifted the Australian Open Superseries trophy in Sydney. In the summit clash, 11th world ranked Srikanth stunned former world number one and Rio Olympics Gold medalist Chen Long of China. The

trophy is Srikanth's second this season and fourth overall. He had won the Indonesian Open 2017.

- ✦ India's Ramkumar Ramanathan lifted the ITF (International Tennis Federation) men's Futures tennis title after outplaying Raymond Sarmiento of the USA in straight sets in Singapore.
- ✦ Muttiah Muralidaran, the most successful bowler in Tests & One-Day Internationals, was inducted into the ICC Cricket Hall of Fame in London.
- ✦ The cricket board for West Indies, on its 91st anniversary, has re-branded themselves as Cricket West Indies from the former West Indies Cricket Board.
- ✦ Never in the history of the UEFA Champions League had a team won the title in consecutive seasons. That is until now — Real Madrid has done it. Now, they stand alone as the only team in the history of the competition to win back-to-back titles.
- ✦ B Sai Praneeth has clinched the Thailand Open Grand Prix Gold badminton title by defeating Indonesia's Jonatan Christie in a closely-fought final in Bangkok.
- ✦ Ganeshan Neelakanta Iyer, the only assigned competition manager of International Table Tennis Federation (ITTF), has become the first Indian to be nominated as a member of the Umpires & Referees Committee (URC).
- ✦ Indian tennis ace Rohan Bopanna & Canadian partner Gabriela Dabrowski produced a fighting performance to beat their German-Colombian opponents Anna-Lena Groenefeld & Robert Farah in the final to clinch their maiden French Open mixed doubles title in Paris, France. Bopanna has become only the fourth Indian to win a Grand Slam crown, after Leander Paes, Mahesh Bhupathi & Sania Mirza.
- ✦ International Olympic Committee has approved new events for the 2020 Tokyo Games, including a number of mixed gender competitions. The additions include a mixed team event for judo. Table Tennis will also get a mixed doubles competition.
- ✦ Michael Venus became New Zealand's first Grand Slam champion since 1974 when he partnered American Ryan Harrison to the French Open men's doubles title.
- ✦ Jelena Ostapenko (Latvia) won her first Grand Slam title by beating Simona Halep 4-6, 6-4, 6-3 in just under two hours in the women's final of the French Open 2017.
- ✦ The French open title 2017 held at Roland Garros in Paris, France. The complete list of all the winners in different categories of The French Open 2017.
 - a) French Men's Singles Open Title- Spain's Rafael Nadal (10th French Title) defeated Stan Wawrinka (Switzerland).
 - b) French Women's Singles Open Title- Latvia's Jelena Ostapenko (1st Grand Slam Title) defeated Simona Halep (Rome).

- ✦ Election Commission of India (ECI) has joined hands with Facebook to launch nationwide voter registration reminder aimed at reminding eligible Indian voters to register themselves on the electoral rolls. In this, Facebook will activate a unique 'Register Now' button reminding all the eligible Indian users to enroll themselves as voters.
- ✦ Equipped with multiple phone lines and computer systems and manned by tech-savvy youngsters, a "mini war room" has been set up in the finance ministry to deal with crises related to the implementation of GST. The unit will act as a quick resource centre for central and state government officials to address their queries on the historic tax reform scheduled to be implemented from July 1. The action room will function from 8 am to 10 pm. It will provide prompt response to queries raised by states and central government officials.
- ✦ Aadhaar is not a valid identification document for Indians traveling to Nepal and Bhutan, according to the Union home ministry. Indians can travel to Nepal and Bhutan- both countries for which they don't need visas - if they possess a valid national passport or election ID card issued by the Election Commission.
- ✦ India has become the 71st country to ratify the United Nations International Convention on Road Transports, TIR. The Convention is a multilateral treaty to boost International Transport of Goods. TIR is managed and developed by IRU - the world road transport organization.
- ✦ Centre has made it mandatory to quote the Aadhaar number for opening bank accounts and for transactions exceeding Rs.50,000. By the Finance Act, 2017, the Government had made it mandatory to seed PAN with Aadhaar and quote it in income-tax returns.
- ✦ India ratified two key ILO conventions on child labor, according to a statement issued by the International Labour Organisation (ILO) in Geneva, Switzerland.
- ✦ The government has set up a GST facilitation cell in Department of Industrial Policy and Promotion (DIPP) to facilitate the rollout of Goods and Services Tax. The cell is headed by Economic Advisor Sudhansu Sekhar Das. It will be the first point of contact for addressing any issue being faced by any sector related to the Department.
- ✦ China-led Asian Infrastructure Investment Bank (AIIB) has approved the membership of Argentina, Madagascar, and Tonga at its second annual meeting of Governors.
- ✦ In China, ahead of the third UN International Day of Yoga, thousands of Chinese would participate in scores

National & International Current Affairs

- ✦ India has contributed \$100,000 to a UN fund to help developing countries actively participate in the discussion of tax issues, becoming the first country to make the contribution. The UN Tax Trust Fund aims to support the work of the Committee of Experts on International Cooperation in Tax Matters.
- ✦ Petroleum Minister Dharmendra Pradhan introduced a new oil and gas block licensing policy that is expected to open up 2.8 million square kilometers of sedimentary basins to exploration and production activities. The Open Acreage Licensing Policy (OALP), a part of the government's Hydrocarbon Exploration and Licensing Policy (HELP), gives exploration companies the option to select the exploration blocks on their own, without having to wait for the formal bid round from the Government.
- ✦ UN Security Council has unanimously approved a resolution sharply reducing the joint United Nations-African Union peacekeeping force in Sudan's troubled Darfur region. The British-drafted resolution will reduce the number of peacekeepers by 44 per cent and international police by about 27 per cent in the Darfur mission.

- ✦ China unveiled the world's first train that operates on a virtual track using sensor technology instead of metal rails. The new trains are battery powered and are nonpolluting. The train's top speed is 70 kilometers per hour, and it can travel 25 kilometers in distance after just 10 minutes of charging.
- ✦ Afghan President Ashraf Ghani inaugurated the first Afghanistan-India air corridor at the Kabul International Airport. The corridor is a direct route that will bypass Pakistan and is meant to improve commerce in Afghanistan. The aim of the route is to create more opportunities and make Afghanistan an exporter country.
- ✦ China has launched world's largest floating solar farm in Anhui province.
- ✦ The World's smallest and cheapest private jet 'Vision Jet' was launched in the USA recently.
- ✦ World Bank has approved financing worth more than 500 million dollars for Afghanistan to support a string of projects to boost the economy, help improve service delivery in five cities and support Afghan refugees sent back from Pakistan.
- ✦ USA designated Pakistan-based Hizb-ul-Mujahideen chief Syed Salahuddin as a specially designated global terrorist.
- ✦ The process for electing the 15th President of India will begin on June 14 with the Election Commission issuing the notification for the polls. The Presidential elections will take place on July 17. The Commission has set June 28 as the last date for filing nominations, while July 1 will be the last date for their withdrawal.
- ✦ India signed the OECD multilateral convention that aims to check cross-border tax evasion by multinational companies. Union Finance Minister Arun Jaitley signed the multilateral convention in Paris, France to implement tax treaty-related measures to prevent base erosion & profit shifting.
- ✦ All 12 major domestic ports will soon switch to renewable energy to meet their entire power requirements, making India the first country to have all Govt.-owned ports running on solar & wind energy. The Govt. plans to install almost 200 megawatt solar & wind power generation capacity at the ports by 2019.
- ✦ India has signed a loan agreement of 36 million dollars with the World Bank for Himachal Pradesh Public Financial Management Capacity Building Programme. The project aims to improve the efficiency of public expenditure management & tax administration in Himachal Pradesh.

- ✦ India & Russia have signed Saint Petersburg Declaration as a roadmap to enhance cooperation after the 18th annual bilateral summit.
- ✦ Nepal has signed a major deal with a China to develop a 1,200 MW Budhigandaki Hydroelectric Project, the biggest hydro project in the landlocked country that could resolve its perennial power crisis.
- ✦ Montenegro has officially joined North Atlantic Treaty Organization (NATO) & hence became the 29th member country of NATO.

Defence Current Affairs

- ✦ The defense arm of the Tata Group has signed an agreement with American firm Lockheed Martin to produce and export new generation F-16 fighter aircraft, potentially kick-starting a mega 'Make in India' project. It is the newest and most advanced version of the world's most successful, combat-proven multi-role fighter.
- ✦ Indian warships began a week-long naval exercise off the coast of Western Australia. The second AUSINDEX exercises are aimed at increasing interoperability between Australian and Indian naval forces, executing complex naval manoeuvres.
- ✦ Defence Research and Development Organisation (DRDO) has successfully test fired the anti-tank missile "Nag" in a desert in Rajasthan's western sector.
- ✦ India successfully test-fired its indigenously developed nuclear-capable Prithvi-II missile from a test range in Odisha as part of a user trial by the Army. The surface-to-surface missile has a strike range of 350 km.
- ✦ India has successfully test-fired its first all weather tracked-chassis Quick Reaction Surface-to-Air Missile (QR-SAM) from a mobile launcher at Integrated Test Range at Chandipur in Odisha.

Ranks/ Indexes Released

- ✦ India has claimed the top spot among the remittance-receiving nations, surpassing China. The United Nations, in its report, stated that Indians working across the globe sent home 62.7 billion US dollars in 2016.
- ✦ India continued to rise in the Global Innovation Index (GII) rankings. In 2017 rankings released in Geneva (Switzerland), India improved its position from 66 to 60. The top three most innovative countries in the list are: 1. Switzerland 2. Sweden 3. Netherlands
- ✦ Connaught Place in the national capital is the most expensive prime office market in India and the ninth

most expensive office market in the world. Hong Kong (Central) became the world's highest-priced office market.

- ✦ According to Mercer's 23rd annual Cost of Living Survey, Mumbai is placed 57th on the list while New Delhi was placed at 99. Chennai (135), Bangalore (166) and Kolkata (184) were the other Indian cities on the list. Luanda, the capital of Angola, was the costliest city, driven by cost of goods and security, followed by Hong Kong and Tokyo.
- ✦ The Forbes list of world's highest-paid celebs is out and has Sean Combs right at the top. On the list, Bollywood big stars with Shah Rukh Khan leading the charge at the 65th position with \$38 million in earnings this year.
- ✦ India has ranked 137th out of 163 countries on Global Peace Index 2017 published by The Institute of Economics & Peace. Iceland has been named the world's most peaceful country while Syria named the least peaceful country.
- ✦ India has been ranked 45th, down four notches from last year, in terms of competitiveness in the annual rankings compiled by IMD which saw Hong Kong topping the list. The list was compiled by the International Institute for Management Development's (IMD) World Competitiveness Center.
- ✦ India has surpassed China to secure the top position among 30 developing countries on ease of doing business, according to a study that cited India's rapidly expanding economy, relaxation of FDI rules & a consumption boom as the key drivers. The GRDI was titled as 'The Age of Focus', ranks China in second place.
- ✦ Indian cricket team captain Virat Kohli is the sole sportsperson from the country to feature in the world's 100 highest paid athletes in the latest Forbes list topped by soccer star Cristiano Ronaldo. Virat Kohli has been ranked 89th on the 2017 Forbes list.

- ✦ International Day Against Drug Abuse and Illicit Trafficking observed on 26 June. The theme for 2017 is-"Listen First - Listening to children and youth is the first step to help them grow healthy and safe."
- ✦ The World Refugee Day is observed across the world on 20 June to commemorate the strength, courage, and perseverance of millions of refugees. The day is celebrated by United Nations.

- ✦ International Day of Yoga is celebrated across the world on 21 June. It aims to raise awareness worldwide of the many benefits of practicing yoga. The theme for the 2017 celebration, organized by the Permanent Mission of India to the United Nations, is 'Yoga for Health.'
- ✦ World Milk Day is an initiative of the United Nations Food & Agriculture Organisation, to celebrate the contribution of the dairy industry around the globe on 1st June.

Agreement Signed

- ✦ An agreement for IBRD Credit of USD 35 Million from World Bank for "Assam State Public Financial Institutional Reforms Project" was signed. The program size is USD 44 million and the remaining(USD 11 million) amount will be funded out of State Budget. The program duration is 5 years. The objective of the project is to improve predictability and transparency in budget execution and efficiency in tax administration in Assam.
- ✦ India and Portugal have signed eleven MOUs for cooperation in areas including double taxation avoidance, science and technology, trade and investment, nanotechnology, space research, administrative reforms and culture. 11 MoU's were exchanged out of which seven and there was the announcement of the launch of a joint science fund for which both India and Portugal will contribute Euros

two million each. 5 of the MoU's were in the area of science and technology. One of the MoU's was signed for the creation of an India Portugal Space Alliance and for advancing collaborative research. These agreements will promote India's science and technology partnership with Portugal, towards the establishment of a unique Centre on the Azores Archipelago - the Atlantic International Research Centre.

- ✦ A Protocol of Cooperation was signed between the National Archives of India and the Minister of Culture of the Portuguese Republic in the field of archives in Lisbon, Portugal. As a first step under this agreement, the Torre do Tombo (National Archives of Portugal) handed over to the National Archives of India digital copies of 62 volumes of the collection known as 'Moncoes do Reino' (Monsoon correspondence).
- ✦ IDBI Federal Life Insurance today said it has partnered with SunTec, which will help facilitate in computing and invoicing of debit tax and credit tax that will be GST compliant.
- ✦ India and Russia have identified key areas to bolster cooperation in the science and technology sector, including space and marine technologies, IT and deep ocean engineering. These were chosen at the first meeting of India-Russia Joint Committee on Science and Technology Cooperation in the Siberian city of Novosibirsk. Also, Inspired by India's 'Make in India' initiative, Moscow has launched a "Do It In Russia" initiative to promote local manufacturing and technology development.
- ✦ Axis Bank in association with Kochi Metro Rail Corporation (KMRL) has launched KMRL Axis Bank 'Kochil' Card, India's first open loop EMV contactless metro card that would make travel a convenient and hassle free experience for commuters in Kochi. - ✦ The Cabinet recently approved:
 - Amendment of the Bilateral Social Security Agreement (SSA) between India and the Netherlands by incorporating the "Country of Residence" Principle into the said SSA.
 - MoU between Ministry of Water Resources, River Development and Ganga Rejuvenation and the Ministry of Infrastructure and the Environment of the Kingdom of the Netherlands for bilateral cooperation in the field of water resources management.

- Constitution of Indian Naval Material Management Service (INMMS) as an Organized Group 'A' Engineering Service.
- MoU on cooperation in the textiles, clothing and fashion sectors between India and Australia

- ✦ Reliance Infrastructure-promoted Mumbai Metro One Private Limited (MMOPL) has partnered with Google to display its services in Google Maps application.
- ✦ National Skill Development Corporation (NSDC) & Bird Academy have signed an MoU to skill more than 30 thousand unemployed youth from across states in the aviation & aerospace sectors.
- ✦ India signed an agreement to provide fresh assistance of 318 million US Dollar credit line to Sri Lanka for the development of the railway sector in the country.
- ✦ An agreement for International Bank for Reconstruction & Development (IBRD) Credit of USD 39.2 Million from World Bank for the project 'Assam Citizen Centric Service Delivery' was signed recently.

- Indian Space Research Organisation's (ISRO) workhorse rocket PSLV C-38 blasted off from the spaceport of Sriharikota, Andhra Pradesh carrying the Cartosat-2 series satellite - a dedicated satellite for the defense forces - along with 30 co-passenger satellites. The co-passenger satellites comprise 29 nano satellites from 14 countries - Austria, Belgium, Britain, Chile, Czech Republic, Finland, France, Germany, Italy, Japan, Latvia, Lithuania, Slovakia, and the US as well as one Indian nanosatellite.
- Indian Mars Orbiter Mission (MOM) also called Mangalyaan completes 1000 Earth days in its orbit on 19th June 2017. The interplanetary mission of ISRO was launched on 5th November 2013.
