c.	Final Degree Certificate & marks sheet along with Conversion Chart issued by the Competent Authority as well as any valid document regarding approval of AICTE of the Institution from which he/she has completed his/her degree course.
d.	Caste certificate (for reserved category for SC/ST candidates)
e.	Domicile certificate
f.	Caste & Creamy layer certificate (For reserved category candidates except SC/ST)
g.	PHP Certificate issued by the competent authority.
h.	Freedom Fighter Certificate, issued by the competent authority.
i.	Conversion Chart issued by Competent Authority.

k.	Aadhar Card

l.	Two colour photographs (as same as uploaded at the time of submission of online application form)

n.	Medical fitness certificate issued by Govt. Civil Surgeon / Assistant Civil Surgeon/ Medical officer of BSPHCL.

4) **The selected candidate will first have to go through the process of Aadhaar verification and after the above; their GATE score will be verified through online method. For this, it will be mandatory to the candidates to appear with the required Enrollment ID/USER ID/ Registration ID, Email Address, Password, Registered Mobile Number etc. for verifying the GATE score from the authorized website of the institute who had conducted the GATE exam in the concerned year. Documents verification will not be completed till the verification of Gate Score Card.**

5) The above provisional list for document documents verification has been prepared purely on the basis of data/ details received / captured in online applications form as well as the action taken against received claim/ objection in reference to the BSPHCL's Notice dt. 06.02.2025. Candidates must note that if any discrepancy in preparation of provisional select list, verification of document, eligibility of candidates for the post, if found in future, BSPHCL reserves the right to amend / rectify / annul it and candidates will not have any right to interfere in the decision of BSPHCL, even after they are finally selected.

6) The candidates are informed that they must be present in person on the schedule date, place and time, before the document verification committee. If they fail to appear for documents verification or fail to bring all required documents / papers, their candidature may be cancelled from the provisional list and no further request shall be entertained.

7) The candidates must note that merely appearing for documents verification, does not entitle them to be considered for appointment. Any claim for appointment on account of the reason that they have been called for document verification, will not be binding on BSPHCL.


