1. This result is provisional.
2. The result has been declared based on candidates' Online Registration for the post without any prior screening of their eligibility. Their candidature remains subject to fulfilling the eligibility conditions outlined in the Detailed Recruitment Advertisement (DRA) Notice No. 171/2025, dated 07.01.2025, and any subsequent notices published on the official website.
3. The list of candidates provided is Sixteen (16) times the category-wise seats advertised in Notice No. 171/2025 and its subsequent addendums/corrigenda, as per the prescribed scheme of examination. However, inclusion in this list does not guarantee employment for the advertised posts. All tie cases have been resolved as per published criteria. Any tie cases with the last candidate called for stage-II: Skill Test in respective category have been included in this list.
4. For posts where seats reserved for PwBD category are advertised, all qualified candidates under PwBD category have been included in the list. In all other cases candidates under PwBD are called

as per published qualifying criteria in respective category subject to point no 3 above. All PwBD candidates are subject to suitability and fitness by medical board constituted by respective Institute. Candidature is always subject to eligibility irrespective of allocation.

5. All candidate must have relevant certificates ready in hand as per DRA valid as on closing date of application and can be submitted as and when required including category certificate.
6. Skill Test will be conducted shortly as per detail published in Notice No.17/2025 dated 10.02.2025. Schedule of same will be published separately. Venue details and reporting time for Skill Test will be notified through Admit Card which can be downloaded from MyPage of the portal using existing credentials at the appropriate time.
7. Individual marks of all candidates who appeared in the examination will be available only after the conduct of stage-II: Skill Test in their Dashboard at www.aiimsexams.ac.in.
8. It is mandatory to appear and qualify in the skill test as per published criteria for further consideration in selection process, where exercise of choice will be called for eight (08) times of qualified candidate in order of merit for exercise of choices for allocation of institute. Any candidate who remains absent in skill test will be treated as not qualified.
9. Candidates must carefully review their eligibility as per published eligibility criteria for respective applicable category (including PwBD) for the post/institute before appearing in skill test. If a candidate is found ineligible at any stage (e.g., due to age, qualification, experience, category certificate or any other conditions), their candidature will be cancelled, even if they have been allocated a seat. In such cases, their selection will be treated as void ab initio.
