IMPORTANT:

1. This result is provisional.
2. The result has been declared based on candidates' Online Registration for the post without any prior screening of their eligibility. Their candidature remains subject to fulfilling the eligibility conditions outlined in the Detailed Recruitment Advertisement (DRA) Notice No. 355/2025, dated 11.11.2025, and any subsequent notices published on the official website.
3. Inclusion in this list does not guarantee employment for the advertised posts. All tie cases have been resolved as per published criteria. Any tie cases with the last candidate called for exercise of choices in respective category have been included in this list.

4. Basic Eligibility checks like Age, Category seat, Set of Qualification or any other criteria as mentioned by candidates in their registration slip for respective posts/Institutes under this Group Code will be carried out before online exercising of choice of Institute.
5. Candidates included in this list may or may not be eligible for the respective post/Institute as the same depends on eligibility during exercising of Choice of Institute.
6. Candidates must carefully review their eligibility strictly as per published eligibility criteria for respective applicable category (including PwBD) for the post/institute before exercising their choices. If a candidate is found ineligible at any stage (e.g., due to age, qualification, experience, category certificate or any other conditions), their candidature will be cancelled, even if they have been allocated a seat. In such cases, their selection will be treated as void ab initio. Therefore, candidates should only select an institute if they meet all eligibility requirements for the respective post/institute.
7. **All candidates must exercise their choice of institute and the order of preference for each Group Code between 30.01.2026 to 09.02.2026**, based on their eligibility for the respective posts/Institute. Seat and Institute will be allocated based on merit cum choice (including order of preference).
8. Mandatory Choice Submission:
 - a. Candidates who fail to exercise their choice within the specified timeline will have their candidature automatically cancelled without any further notice.
 - b. Such candidates will forfeit all claims regarding the applied post, and no allocation rights will be available at any stage.
 - c. If a candidate is called for choice submission but does not submit any choices, they will be excluded from further recruitment stages, and their candidature will be summarily rejected.
 - d. If a candidate submits choices for only some of the available institutes but not for all, they will be considered only for the posts/institutes they have selected and not for the ones they omitted, even if seats are available.
9. All PwBD candidates are subject to suitability and fitness by medical board constituted by respective Institute. Candidature is always subject to eligibility irrespective of allocation.
10. All candidate must have relevant certificates ready in hand as per DRA valid as on closing date of application and can be submitted as and when required including category certificate.
