1. It is for the information of the candidates who had appeared in the written competitive examination for recruitment to these posts held on **04/01/2026** that the candidates mentioned in the list attached as **Annexure- A** have been provisionally shortlisted.
2. As per proviso 8.6 of "General Information for the Candidates", the candidates of Annexure- A are directed to submit their online hard copy of application form along with copy of all the eligibility documents **in person only** on **10.02.2026 and 11.02.2026** (10:00 A.M. to 1:00 P.M.) in the office of Punjab Public Service Commission, Baradari Gardens, Patiala for scrutiny of documents, failing which their candidature for the ibid posts may be cancelled.
3. The Candidates **MUST** bring the following Self Attested Certificates/documents along with signed copy of printout of online application form:-
 - (a) Proof of Date of Birth: Certificate of Matriculation / Higher Secondary,
 - (b) Proof of having passed Punjabi Language.
 - (c) Proof of having B.A./B.Sc. Examination with Social Science, Social Work, Sociology, Child Development, Nutrition, Psychology, Economics, Philosophy or Anthropology as one of the subjects from a recognized university or institution
 - (d) Reserve Category Certificate issued by the Competent Authority (if applicable).
 - (e) Latest Punjab Residence certificate (for all Reserve Categories also including the Female or EWS candidates who have applied in General Category) issued by competent authority.
 - (f) ESM certificates/documents mentioning the following (if applicable):
 - i) Date of Enrolment.
 - ii) Date of Release/Discharge.
 - iii) Reasons of Release/Discharge.&
For LDESM candidates produce original LDESM certificate (if applicable)
 - (g) Certificate as proof of age relaxation claim (if applicable).
 - (h) Certificate as proof of fee concession (if applicable).
 - (i) Proof of being Govt. employee (if applicable).
 - (j) Copy of Bank Challan (PPSC Copy only)
 - (k) Any other certificate (if applicable).

4. Candidates are also required to bring original certificates/documents at the time of submission of document copies for Scrutiny.
5. The application forms and requisite documents of candidates at Annexure -A shall be scrutinized by the Commission. During the scrutiny of application forms, if any provisionally shortlisted candidate is found ineligible, then his/her candidature shall be cancelled by the Commission.
6. While every care has been taken in preparing and uploading the list of provisionally shortlisted candidates at Annexure-A for scrutiny of documents, possibility of inadvertent/technical errors cannot be ruled out. The Commission reserves the right to rectify the same at any stage.
