**For Post code: 806/23, PGT (Physics) – Male in Directorate of Education, GNCTD, PGT (Physics) – Female in Directorate of Education, GNCTD and PGT (Physics) in New Delhi Municipal Council under Post code 806/23**

1. The DSSSB vide its advertisement no. 07/2023 dated 22.12.2023 with closing date 07.02.2024 & Corrigendum no. 5070-81 dated 19/02/2024 had advertised total **09 vacancies {04 vacancies for PGT (Physics)-Male (UR-01, OBC-02, ST-01, Incl. PwBD (Cat. b)-01), 04 vacancies for PGT (Physics)- Female (UR-01, OBC-01, SC-02, Incl. PwBD (Cat. b)-01 & Incl. PwBD (Cat. c)-01)}** in Directorate of Education, GNCTD, and PGT (Physics) (UR-01) in New Delhi Municipal Council (NDMC) under Post code 806/23
2. The written examination (online mode) Tier-I for recruitment in respect of this post was conducted on 30<sup>th</sup> July 2024.
3. The marks statements of **1288 candidates** who appeared in the Tier-I examination (online mode), of the above post code were uploaded on the Board's website vide **Notice No. 297 dated 20.11.2025**. Out of 1288, only 48 qualified candidates were shortlisted to upload documents in e-dossier module and exercise at least one preference in OARS from 25/11/2025 to 09/12/2025 subject to attaining minimum qualifying marks and correctness of the information furnished by the candidates in their online application form.
4. As per the provisions of the Notice no. 297 dated 20/11/2025, allocation of posts/Departments to eligible candidates has been made on the basis of Merit-cum-Preference of posts submitted by the candidates on preference module during filling e-dossier in the OARS module. **Once a post/department is allocated, no change of posts/departments will either be entertained or allowed by the Board.**
5. The result has been processed purely on the basis of marks obtained by the candidates in the examination held on 30.07.2024 and also claims made by the candidates in their online application forms of the post code 806/23 for the post of PGT (Physics) – Male in Directorate of Education, GNCTD, PGT (Physics) – Female in Directorate of Education, GNCTD and PGT (Physics) in New Delhi Municipal Council under Post code 806/23. **The Board has not undertaken scrutiny of documents uploaded in the e-dossiers at this stage, as per Board's resolution / decision dated 14.07.2022.** The eligibility as per Recruitment Rules and other terms and conditions as specified in the advertisement number 07/23 and relaxations as per rules in respect of educational qualifications, age experience, etc., shall be scrutinized/verified by the User Department for determining eligibility of the candidates for the post code 806/23, as on **cut-off date 07.02.2024** before issuance of offer of appointment to the post.
6. On the basis of marks secured in the online written examination and considering other relaxations, if any, claimed by the candidates in their online application forms, the candidates having following Roll Nos. (One Tier-Technical/Teaching) are hereby **provisionally nominated** for the post of **PGT (Physics) – Male in Directorate of Education, GNCTD, PGT (Physics) – Female in Directorate of Education, GNCTD and PGT (Physics) in New Delhi Municipal Council**, subject to fulfilment of all other conditions of eligibility and also correctness of the information furnished by the candidates in their online applications forms and e-dossiers: -

7. The provisional nomination of the above mentioned **Total 08 candidates (UR-01, UR-PwBD-02, OBC-03, SC-01, ST-01)** i.e. (UR-PwBD-01, OBC-02, ST-01)-for the post of PGT-Physics (Male) in DoE, (UR-PwBD-01, OBC-01, SC-01)- for the post of PGT-Physics (Female) and (UR-01)- for the post of PGT- Physics in NDMC, on the basis of their claims in their applications shall be subject to thorough verification of their candidature by the User Department including the identity of the candidates as per services department Circular No. F.16(3)/2007/S-III/1756-1763 dated 02/08/2021.
8. The provisional nomination of the above candidates shall further be subject to genuineness of the documents on the basis of which they have claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of advertisement and subject to thorough verification of their identity with reference to their photographs, signature/ handwriting etc. on the application form, admission certificate etc. by the User Department. The candidature of the candidate is liable to be cancelled by the User Department, in case, candidate does not fulfill any of the eligibility conditions of the Recruitment Rules for the post or for any genuine reason. The decision of the User Department regarding the eligibility of the candidate shall be final and binding on the candidate. The Competent Authority of the User Department concerned shall issue the offer of appointment to the candidate after being satisfied about his/her eligibility as

laid down in the recruitment rules and after verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age and other essential qualifications.

9. The User Department shall also check the eligibility of the reservation benefit claimed by the candidates, if any. Further, User Department shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidate, if applicable. The Competent Authority of the User Department shall arrange to verify the correctness of the information/ documents as furnished in the application forms and e-dossier vis-à-vis the original documents. The User Department is requested to ascertain the scrutiny/correctness of the same at its own level before issuing the offer of appointment to the provisionally selected candidate. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also requested to rectify/correct, in case, any minor/clerical error/deficiency noticed in the documents of the candidate at its own level.
10. It is stated that the User Department shall verify the genuineness of the caste certificate furnished by the candidate in the light of Notification No. 36012/22/93-Estt. (SCT) dated 08/09/1993 issued by DOPT and other instructions/ guidelines issued from time to time by the competent authorities prior to issuance of offer of appointment to the candidate. It is further stated that, prior to appointment, the User Department must satisfy, itself, that the above candidate is fulfilling the necessary criteria as prescribed for entitlement of OBC(Delhi) certificate as specified in various Orders/Guidelines/Circulars including order dated 07/03/2017 issued by Revenue Deptt, GNCTD after thorough verification of caste certificate.
11. The User Department shall also get the SC/ST/OBC/EWS/PH (with sub category) certificates verified from the issuing authority. Further, in case of the OBC candidates, it may also be verified that the candidate does not belong to creamy layer of the schedule of Govt. of India, DOPT O.M. No. 36012/22/93-Estt. (SCT) dated 08.09.1993, O.M. No. 36033/3/2004-Estt. (Res) dated 09.03.2004 and 14/10/2008 and 36033/1/2013-Estt. (Res) dated 27.05.2013 & 13.09.2017 and other instructions/ guidelines issued from time to time by the competent authorities.
12. Further, in case of EWS candidates, it may also be verified that the validity of EWS certificate should be as per DOPT OM No. 36039/1/2019-ESTT(Res) dated 31.01.2019 and other instructions/ guidelines issued from time to time in this regard by the competent authorities.
13. At this stage, DSSSB has not undertaken the veracity/scrutiny of experience certificates furnished by the candidates. As such User Department i.e. Directorate of Education, GNCTD & NDMC will ascertain the equivalence/ scrutiny / correctness of the same at their own level before issuing the offer of appointment to the proposed candidates. The nomination by DSSSB is provisional and subject to the satisfaction of User Department.
14. The Competent Authority of the Department concerned shall issue the appointment letter to the candidates after verification of the correctness of the information furnished in the application form/e-dossier and the documents related to education qualification, age and other essential certificates including caste certificate as per Government of India instructions issued in this regard **vide MHA OM No. 2/29/54-RPS, 19/11/54.**

15. The User Department shall ensure that the appointment made is in conformity with DOPT guidelines and instructions of Govt. issued from time to time.
16. While every care has been taken in preparing the result, the DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.
17. The Post/Department and category wise cut-off details of last selected candidates against each is as under: -

18. Mere inclusion of the name of the candidate in the result notice does not confer any right upon the candidate over the post unless the User Department is satisfied after such inquiry as may be considered necessary that the candidate is suitable in all respects for appointment to the post.
19. The recruitment process for the Post of Post Code 806/23, PGT (Physics) – Male in Directorate of Education, GNCTD, PGT (Physics) – Female in Directorate of Education, GNCTD and PGT (Physics) in New Delhi Municipal Council has been closed.
20. There is no waiting list or Reserve Panel under combined examination as per Notice cum corrigendum No.5070-81 dated 19/02/2024. Unfilled vacancies and vacancies arising out of non-joining of nominated candidates will be carried forward to the subsequent year(s) by the concerned User Departments.
21. While every care has been taken in preparing the result, DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.
