**Sub: - NTA Declares the Result/NTA Scores of Common University Entrance Test (UG) – 2023 – Reg.**

The National Testing Agency has been mandated by the **Ministry of Education and UGC** to conduct Common University Entrance Test (CUET) for admission into **Undergraduate Programmes in Central Universities under the Ministry of Education, and other participating Universities / Institutions / Organizations / Autonomous Colleges** for the **Academic session 2023-2024**.

CUET (UG) provided a **single window opportunity to students seeking admission in any of the Central Universities (CUs) or other participating organizations (including State Universities, Deemed and Private Universities) across the Country** especially those from rural and other remote areas, help establish better connections with the Universities. A single Examination enabled the Candidates to cover a wide outreach and be part of the admissions process to various Central Universities and other participating Universities.

The National Testing Agency conducted Common University Entrance Test (UG) – 2023 [CUET (UG) – 2023] in Computer Based Test (CBT) Mode for about **14,99,790** (Fourteen Lacs, ninety-nine thousand, seven hundred and ninety) **unique registered candidates** who opted for **64,35,144 Test Papers**. These candidates applied for **48,779** unique combinations of subjects across **250** Central, State, and other participating universities / Institutions / Organizations for the **Academic session 2023-2024** at various Examination Centres located in different cities across India and abroad, as per the following schedule.

CUET (UG) – 2023 was conducted in **nine Phases** for admission in the academic session 2023-24 in Computer Based Test (CBT) mode as per the following details:

The CUET (UG) – 2023 provided access and flexibility in the following ways:

- The candidates have applied for **64,35,144** unique combinations of subjects across **250** Universities.
- The total number of Question Papers was **2305** and the number of Questions was **148520**. These were used over **34 days and 93 Shifts**.
- The medium of the Question Paper was in **13 languages (English, Hindi along with regional languages i.e. Assamese, Bengali, Gujarati, Kannada, Malayalam, Marathi, Odia, Punjabi, Tamil, Telugu, and Urdu)** so that the candidate from different regions could attempt in their own medium and feel comfortable to write and understand the pattern/method of the examination.
- An overall choice in all subjects was given to all candidates in order to cater to the decision of different Boards across the country regarding the reduction of the syllabus. In all subjects, candidates had to attempt any 40 questions out of 50 except for the General Test where 50 questions were to be attempted out of 60
- In addition to 285 cities in India, CUET (UG) - 2023 examination was also conducted in **23 cities outside India in Manama, Doha, Dubai, Kathmandu, Muscat, Riyadh, Sharjah, Singapore, Kuwait City, Ottawa, Oslo, Port Louis, Sydney, Moscow, Vienna, Washington DC.**
- Grievances of individual students based on their experience in CUET (UG) – 2023 have also been considered.
- A number of opportunities to make corrections in the particulars of online Application Forms were given to facilitate the candidates.
- For the preparation of Question papers, **about 2200 subject Experts and 800 translators** were involved in the massive exercise of preparing the Question Papers for CUET (UG) – 2023.

Candidates were given an opportunity for the challenge from **29 June to 01 July 2023** along with the Provisional Answer Key, Question Paper, and Recorded responses. In this duration, about **25782** Answer Key challenges were received out of which **3886** were the unique challenges. Candidates were also given representation through e-mails and letters. Those were also shown to the concerned Subject Experts. Based on their feedback and after incorporating the changes, the Final Answer Keys were prepared which were used in preparing the Result of CUET (UG) – 2023.

The performance of every candidate has been evaluated using the equi-percentile method wherein normalized marks of each candidate have been calculated using the percentiles of each group of students in a given session across multiple days for the same subject. The Examination was monitored in the following ways:-

- A Central Control Room was opened to monitor and facilitate the smooth conduct of the Examination on the ground. **02** National Coordinators, **19** Regional Coordinators, **303** City Coordinators, **1083** Observers, and **162** Deputy Observers were deployed.
- Live CCTV Surveillance was planned in all examination centres to curb malpractices in the examination. The NTA also made arrangements for live viewing of remote locations of all examination centres from the Control Room located in the NTA premises of New Delhi. Recording of CCTV Systems was also done.
- The examination centres were also monitored using AI-based Video Analytics and Virtual Observers.
- In order to stop cheating using mobile networks, Jammers were installed in all the Centres.

Candidates were given an opportunity to see their responses to the Question Papers and to challenge the Answer Keys. Challenges received online were placed before the concerned Subject Experts for verification. The result was prepared based on the Final Answer Keys and the same is being declared today i.e. **15 July 2023** on <https://cuet.samarth.ac.in/>

## Annexure 1

### Initiatives taken by the NTA to facilitate the candidates:

In order to ensure more participation from the candidates throughout India and to facilitate them, NTA opened CUET (UG) – 2023 Examination Help Centres to ensure awareness and to help provide equal opportunities to the candidates, especially from rural and remote areas.

The Centres were opened in **Kamrup, Amritsar, Kota, Jaipur, Jalandhar, Mumbai, Ernakulam, Trivandrum, Durg, Khurda, Chennai, Chittoor, Ambikapur, West Champaran, Ghaziabad, Bengaluru, Malajgiri, Kurnool, Malda, Kangra, Vijayawada, Leh, Srinagar, Anangnag, Baraulla, Pulwama, Ahmedabad, Kollam, Bilaspur, and Narsinghar.**

Each Centre had one dedicated Technical person in charge who helped the candidates in filling the Application Form online. The candidates could go to their near Help Centre with the required documents and fill in the form. **This Helpline service was provided free of cost.**

Moreover, in the UT of **Jammu & Kashmir** where a phenomenal increase of candidates was witnessed in 2023, the NTA facilitated the creation of an NTA Centre to accommodate candidates from J & K. A total of 1,31,149 candidates were scheduled out of which 91,425 candidates appeared in the UT of Jammu & Kashmir. In the NTA Centre, Srinagar, a total of 12,473 candidates took the examination.

For the UT of **Ladakh**, 3632 candidates registered wherein 2505 candidates appeared in Leh and Kargil. Special efforts were made to ensure candidates are given centres in their own city wherever possible.

The State of **Jharkhand** also saw an upsurge this year, where 2,50,017 candidates were scheduled, out of which 1,83,852 candidates appeared. To facilitate candidates, an NTA Centre was also opened at Ranchi University so that more candidates could be accommodated in the State. In NTA Centre, Ranchi, a total of 14,466 candidates be refitted.

As far as **Manipur** is concerned, there were about 6753 candidates registered out of which 3225 candidates took the examination in Imphal city. The candidates who earlier opted to appear in Manipur for the CUET (UG) – 2023 examination were given an opportunity to change their city through the Interactive Voice Response System (IVRS) facility. NTA carefully reviewed the law-and-order situation in consultation with the State Administration and contacted these candidates by telephone (IVRS) for asking their preferred city for the said examination. Some candidates who were not in Manipur or wanted to take the examination in another State/City are being allocated to other cities i.e., Delhi, Guwahati, etc.

The option to change the City for the examination was also made available to those candidates in the state of Manipur who had not appeared in/missed the CUET (UG) – 2023 examination due to the law and order situation, irrespective of whether they had downloaded their Admit Cards or not.

One of the Cities which the candidates of Manipur could opt for the above-mentioned examination(s), were *Aizawl (Mizoram), Kohima/Dimapur (Nagaland), Shillong (Meghalaya), Guwahati (Assam), Jorhat (Assam), Silchar (Assam), Kolkata (West Bengal), Delhi, Bengaluru (Karnataka), Imphal (Manipur)*.

The Exam City option was made available to the candidates of Manipur through the Interactive Voice Response System (IVRS) facility. A message in this regard was sent to each candidate on his/her mobile number registered with the online application form for the respective exam. On receipt of city change options from the willing/interested candidates, they were allocated an exam Centre in the preferred City and their Admit Cards were issued accordingly.

There were 2328 candidates from Pauri Garhwal, Srinagar, Uttarakhand who were also accommodated and 1625 took the examination in Srinagar, Uttarakhand itself.
